SCHEDULE I. STOP INTERSECTIONS.

(A) It shall be unlawful to disobey the following traffic-control measures.

(B) Stop signs shall be erected at the following locations:

The streets and intersections shall be through streets at the places set forth as follows, and shall be marked by signs as through highways in those locations.

SCHEDULE VI. SKATEBOARDS, ROLLER SKATES, AND THE LIKE; RESTRICTED AREAS.

(A) *Restricted areas.* No person shall operate, propel, or ride a skateboard or other similar device, or in-line skates or roller skates, in the following locations:

(B) *Exceptions.* In-line skating and roller skating only shall be allowed in the following areas:
