Project Overview

The 2024 110th Avenue Improvement Project will include work on 110th Avenue (between 150th Street and 160th Street). The work will include installation of sanitary and water main in the area of the intersection of 110th Avenue and 150th Street, along with various culvert installations and bituminous paving over the length of the project. The work is scheduled to begin July 8, 2024 and conclude late October
